## Consultation

The draft Regional Flood and Coastal Committee (RFCC) Business Plan was published for public consultation on the 7<sup>th</sup> December 2018 for nine weeks until the 8<sup>th</sup> February 2019. Partners and the public were offered the opportunity to respond to the consultation online via the Flood Hub or Citizen Space websites, by email or by post. The following report summarises the responses to the consultation.

### Overview

The North West RFCC business plan was produced to structure the objectives and principle work streams for the period April 2019 and March 2022.


The plan sets out the committee’s priorities to ensure it fulfils its responsibilities now and looks ahead and outwards to better understand future challenges.

The business plan looks to compliment the Government’s 25 year Environment Plan and the refreshed National Flood and Coastal Erosion Risk Management Strategy currently in development.









## General Comments

- A common theme in the responses was that the business plan could benefit from a clearer structure which includes sharper images and clearer graphs and tables
- Coastal risk could be expanded and integrated into the document more
- Pleased to see that the business plan supports Defra’s 25 Year Environment Strategy
- As well as the risk to homes which is a strong message throughout the plan, businesses and infrastructure need to feature more strongly
- Approval for the move from vision themes to longer term goals
- The Flood Hub is a great resource and its development and maintenance should therefore be a priority
- As a business plan, an action plan and cost expenditure profile would be expected
- Surface water flooding is raised as an issue throughout, but could this be expanded on to discuss how the RFCC is going to invest in surface water flood risk
- Good to see an ambitious plan
- Respondents found it difficult to rank the objectives as they were all considered equally important

## **Next Steps**

The Business Plan will now be amended taking the feedback into account as far as possible. This includes the following commitments:

- To make it more concise and more clearly structured, simplifying the presentation of our aims (mission statement, themes, goals and objectives)
- To move some of the existing content to The Flood Hub website, especially that which is likely to change over time
- To increase the emphasis on coastal flood risk and erosion management throughout the plan
- To provide more detail on how we will address surface water flood risk as a priority

A final version Business Plan will be presented to the Committee for approval in July 2019. It will then be published on The Flood Hub website.
