Project update / Flood Scheme update

We are pleased to announce that the Radcliffe and Redvales FRMS £40 million project has now had its final business case signed off, Phase 1 planning permission approved and the contracts have been awarded for construction of Phase 1 and the detailed design and construction of Phase 2.

A series of walls and embankments will be constructed in Phases 1 and 2 along the River Irwell that will reduce the risk of flooding to 873 properties.

The construction of Phase 1 will start in mid-June with work taking place in Close Park and off Dumers Lane and Morris Street. The proposed replacement of Hardy's Gate Bridge will no longer take place, but some minor alterations will take place as part of Phase 2. We will be holding regular, informal community engagement sessions at the Ranger Hut once construction has started - keep an eye on the park and project noticeboards for these dates.

The design of Phase 2 is continuing and will be completed during summer 2019. The planning application for Phase 2 will be submitted in September with the construction to follow on from the completion of Phase 1. The deadline for completion of the defences (excluding landscaping and environmental works) is still March 2021. There are still hurdles to get over, particularly planning for Phase 2 but the project is moving forward and the project team and our partners Bury Council remain committed and positive on our achieving completion the scheme by March 2021.

Bury Council Update

Recent development proposals

National and local planning policy is clear that new developments shouldn't be granted planning permission if they would be at risk of flooding – or if they would increase risk of flooding for existing properties. Applications for development in flood risk areas therefore have to demonstrate, through a flood risk assessment report, that they won't increase flood risk. If the risk is from a main river, the Council consults the Environment Agency, which advises whether a flood risk assessment does indeed demonstrate no increase in risk. Bury Council won't approve a planning application that the Environment Agency has maintained an objection to.

Development proposals which may be of interest include:

- Warth Road 65 houses (ref no 60424), this development is now complete.
- York Street 143 houses and business unit (56744, 60418, 60691) This is a 2015 approval but a revised proposal is expected.
- Morris Street 14 houses (55583) Planning permission has now expired.
- Former East Lancs Paper Mill site (62969) Outline planning permission was given in December 2018 to a development of up to 400 new homes along with extensive areas of public open space and new sports provision.


