

## **Appleby Flood Risk Management Scheme Update**

August 2019

The Environment Agency are striving to improve the existing Flood Risk Management Scheme from summer 2020. This is to better protect residential and business properties in Appleby from future flooding. Some of the benefits of the scheme include;

We last engaged with you in February 2019 where we notified you of our short list options for The Sands and Town Centre area. Since then we have been refining the short list options to try and find a Flood Risk Management Scheme that is economically viable, technically feasible, environmentally sustainable and socially acceptable for the community of Appleby.

This has been particularly challenging economically for Appleby due to the relatively small numbers of properties requiring protection compared with the cost of building a flood risk management scheme. We were required to secure substantial partnership funding to make the scheme economically viable which we have been unable to do. We have , however, challenged the original government funding allocation of £750k and have been able increase this to £1.5m for the Town, but this will only enable us to deliver some flood risk benefits for Appleby.

#### We have identified key areas within Appleby that require intervention and we are aiming to deliver the following:-

- Culvert improvements at Rampkin Pastures which improves the conveyance of water through the culvert, increasing
  the efficiency of the existing basin where flood water collects and is stored
- Installation of a new pump on Doomgate Beck we are still focusing on delivering a sump and pump which will allow
  flow coming through the Doomgate culvert to be effectively discharged into the River Eden even when the River Eden is
  high. This will mitigate a significant residual risk that remains behind the existing defences
- Raise low spots and carry out strengthening works on the existing defences If deemed necessary following the structural and geotechnical assessment. This will ensure the Town Centre has a consistent standard of protection
- Potential Improvements to the existing Property Flood Resistance measures on The Sands as a riverside flood wall
  was not economically viable

We are also continuing to investigate the removal of Bongate Weir that is located upstream of Appleby Town Centre. The weir is in a poor state of repair that creates dangerous currents posing a health and safety risk as well as being a barrier to fish navigating the river. We are working with Eden Rivers Trust, Cumbria County Council and Eden District Council to develop a plan for removing this weir.

#### What happens now?

- We are continuing to develop our proposals for the above works and refine the costs of delivery by the end of September 2019
- We will present our proposals to you in Autumn 2019
- Subject to community feedback on our proposals we will apply for planning approval in early 2020
- Delivery of the improved flood risk management scheme will start in Summer 2020
