Project update / Flood Scheme update

The project team have had a successful start to the construction of Phase 1 of Radcliffe and Redvales FRMS where you may have seen that the piling works at Close Park are underway and construction works have started on the embankment. The project offices at Morris Street Compound are up and running and surveys are currently being completed on Dumers Lane ahead of starting the piling works. Work in Close Park has progressed well but we have experienced some delays, particularly around Dumers Lane and Morris Street. Overall, these are not expected to have a significant impact on the project and we are doing all we can to regain some of the lost time.

Phase 2 Planning Applications will be submitted in autumn 2019. There are 3 applications being submitted:

- Warth Business Park;
- Keswick Drive
- Lower Hinds, Bury Point, Redvales Business Park and the minor alterations to Hardy's Gate Bridge.

The project team have been working with stakeholders affected by the design and construction and we thank them for their cooperation and understanding. The detailed design of the defences will be completed once the planning application is submitted.

Construction of Phase 2 will start following completion of Phase 1. The deadline for completion of the defences (excluding landscaping and environmental works) is still March 2021. The project team and our partners Bury Council remain committed to achieving completion of the scheme to reduce the risk of flooding to 873 properties by March 2021.

Bury Council Update

Recent development proposals

National and local planning policy is clear that new developments shouldn't be granted planning permission if they would be at risk of flooding – or if they would increase risk of flooding for existing properties. Applications for development in flood risk areas therefore have to demonstrate, through a flood risk assessment report, that they won't increase flood risk. If the risk is from a main river, the Council consults the Environment Agency, which advises whether a flood risk assessment does indeed demonstrate no increase in risk. Bury Council won't approve a planning application that the Environment Agency has maintained an objection to.

Development proposals which may be of interest include:

- York Street 143 houses and business unit (56744, 60418, 60691) This is a 2015 approval but a
 revised proposal is still expected.
- Former East Lancs Paper Mill site (62969) Outline planning permission was given in December 2018 for a development of up to 400 new homes along with extensive areas of public open space and new sports provision. A reserved matters application is expected.

The Flood Hub Website is now live



Springwater Group

The Springwater Group is local people who feel passionate about the park working together to improve its image so that more people in the community can enjoy and explore.

Springwater Park is a well-used and well-loved green space in Whitefield, Bury, Greater Manchester. It lies at the edge of densely populated areas of housing and busy roads, but inspite of this it is a beautiful and peaceful green area comprising riverside plains and gently rolling woodland, which is wonderfully wild and natural. Springwater is a haven for wildlife, as well as being a haven for local people who use the space to play, exercise, picnic, bike, swim, climb, run, walk and relax.

Unfortunately over recent years Springwater Park had suffered neglect, causing it to become rundown and a target for anti-social behaviour. This prompted a group of local residents to come together to form LOVE SPRINGWATER PARK with the aim of halting this decline, and beginning to improve the park. Since the group formed in autumn 2017 we have cleared pathways, begun woodland management, cleared back over 5 hectares of overgrown land, begun tackling invasive species which pose a danger to people who visit the park and which would destroy natural ecosystems if left unchecked, removed sacks and sacks and sacks and sacks of rubbish, and hosted our first community event in our newly created community space in April.
