We asked Andy why he felt the Preston and South Ribble Flood Risk Management scheme was so important...

'In terms of flood resilience for the Environment Agency and our partners in this project then this is a once in a generational opportunity for us to get it right, get on and get it done.

Our aim is to reduce the risk of flooding to people who live and work in what are currently areas at risk from flooding now and in the future. Alongside that, the work we are doing can and should act as a catalyst for enhancement to the local area. Storm Ciara & Storm Dennis

Several communities across Lancashire were flooded recently as a result of Storm Ciara, Dennis and other February 2020 storms. London Road and Lower Penwortham was particularly affected with many reports of flooding to businesses and homes. Local road and rail networks were also impacted as well as the brief closure of the southbound section of the M6 around junction 31.
