


Kendal Flood Risk Management Scheme Planning Conditions key facts

There are 28 planning conditions associated with the delivery of the Kendal Phase One Flood Risk Management Scheme. These conditions are a combination of actions that we need to undertake and/or demonstrate to South Lakeland Planning Authority before we can start, or during construction works. Many of the conditions require us to work with others to develop our plans and strategies. This ensures we build a scheme that not only blends into the local landscape, but improves the wider environment for people and wildlife.















Pre-commencement conditions - progress tracker

Working with partners, key groups, and stakeholders we have produced a number of documents and plans to support the discharge of the pre-commencement and associated planning conditions. The table below documents progress made in discharging these conditions.

7	Submit plan for protecting trees as shown in Tree Removal/Retention Plan. 22	Log Surface water drainage outfalls during construction.	Consultation completed with Cumbria County Council.	Submitted documentation. Further consultation will continue subject to pipework and outfalls being identified during construction.
23	Submit mitigation measures to control dust.	Consultation completed with South Lakeland District Council Environmental Health Officer and specialist consultant.	Submitted dust management and monitoring plan. Installation of monitoring equipment and active monitoring results to be reported.
24	Related to working hours during construction.	Consultation to take place if we need to work outside of agreed working hours.	Only if working outside of agreed working hours.
25	Submit a Phase One Contamination Assessment.	Consultation completed with Environment Agency and South Lakeland District Council environmental Health Officer.	Submitted documentation on human health and environment effects. Further work required if we find contamination during construction. Verification report to be submitted on completion.
26	Submit a Construction Environmental Management Plan (CEMP).	Consultation completed with South Lakeland District Council and Natural England.	Submitted an overarching CEMP and will be submitting reach specific biodiversity protection and risk assessments ahead of starting each reach.
27	(linked to condition 27) Submit a biosecurity protocol.	Consultation completed with South Lakeland District Council and Natural England.	Submitted.
28	(Appendix to Condition 26) Submit a biodiversity monitoring strategy.	Consultation completed with South Lakeland District Council and Natural England.	Submitted Monitoring Strategy and will submit reports on the finidng of monitoring activity (Bats)
