An update from the Environment Agency,

Welcome to the Spring 2023 edition of the Hambleton Flood Risk Management Scheme (FRMS) Newsletter.

Hambleton FRMS Overview:

A large part of the village is in flood zone 3 which is an area with the highest probability of flooding. The risk of tidal flooding in Hambleton is likely to increase in the future as a result of climate change.

The existing defences do not provide a consistent standard of flood protection. Intervention is therefore required to ensure the longer-term safety of the community in Hambleton.

The new flood defences will better protect over 600 properties.

Linear flood walls are proposed from Kiln Lane, (north of Wardleys Pool), to the end of the existing embankment near Peg's Pool.

The embankment in Zone 4 will be raised to combat climate change.

The Hambleton FRMS will provide a consistent standard of protection against a flood event with a 0.5% chance of occurring in any one year and accounts for climate change.

Scheme update

Since work resumed on the project in Summer 2020, work has progressed on the detailed design of the scheme alongside discussions with statutory stakeholders to secure the necessary permissions required to build the scheme.

We have continued to refine the design of the scheme to ensure that the proposals we submit for planning deliver the most effective scheme for the community, while minimising the disruption of the construction phase to those residents who will be most affected. We have consulted extensively with Natural England and Lancashire County Council regarding elements of the works for which they are statutory consultees and have also engaged with Wyre Council, the Marine Management Organisation and the Open Space Society as we prepare our planning submission for the scheme.

We continue to engage with individual stakeholders and members of the community on elements of the detailed design.





Compensatory Habitat

A new component of our scheme is the delivery of a compensatory habitat site at Rawcliffe Road, approximately 3km upstream of the main flood risk management scheme.

An area of land has been purchased for the proposed compensatory habitat works. A new flood defence, set back from the river will be constructed and the existing informal defences will be breached. The site will inundate under tidal conditions which will enable new habitat to establish.

The FRMS works along the Hambleton frontage will have an impact on the existing saltmarsh communities. Through our consultation with Natural England we have committed to develop a compensatory habitat site which will provide in excess of 2 hectares of intertidal habitat. It is expected that the majority of the existing saltmarsh communities on the Hambleton frontage will recover once construction is complete leaving a net gain in biodiverse habitat for the area. We continue to work closely with Natural England to ensure that this habitat is delivered effectively.

Opportunities for Environmental Enhancement

Whilst preparing the scheme we have been working to enhance the local environment. Proactive tree planting has taken place on Saltmarsh Lane to compensate for vegetation loss that will arise from the construction works. Trees and hedgerows will need to be removed to enable construction of the scheme.
