## Kendal Flood Risk Management Scheme **Business Resilience Guide**

The Environment Agency estimates 185,000 businesses in England and Wales are in an area at flood risk. By planning and preparing you can work towards making your business more resilient. A flood resilient business may experience less of an impact if a flood occurs, allowing for business continuity. From creating a flood plan, to protecting your products, there are many resources available to help you plan and prepare for flooding to your business.

#### 1. Know your flood risk

You can find out whether your business is at flood risk by visiting www.gov.uk. This free service will provide information on:

- the long term flood risk for your area
- the possible causes of flooding in your area
- how to manage flood risk

### 2. Be prepared

Ensuring your business has an effective flood plan in place will enable you to respond to flooding more efficiently. You can do this by creating a basic action plan, signing up multiple people or staff to receive flood alerts and warnings, and ensure you have adequate flood insurance cover.

### 3. Business continuity

An additional consideration to make your business more resilient is to understand any flood risk impacts to your business supply chain. By implementing steps to minimise risks will protect your ability to continue to operate.

#### 4. Flood insurance

It is important that your business is fully insured and covers high value items such as equipment and machinery. There are a number of options available for commercial flood insurance and include;

- Tailored policy through a broker
- Flood excess insurance
- Parametric insurance
- Self insuring

### Scheme construction – supporting business continuity and resilience

The Environment Agency are constructing a multi-million pound flood risk management scheme to better protect homes and businesses from future flooding. The scheme being delivered along the river corridor in Kendal will span over four years and will directly impact a number of riverside businesses. This guide will provide information on business support available to any business directly impacted by our construction works to ensure business continuity and resilience during this time.

Businesses can suffer financial losses as a direct result of our works in a number of ways;

- Reduced footfall due to access restrictions
- Road and footpath closures
- Closures of parking areas
- Restrictions for deliveries and collections
- Reduced business visibility and/or advertising signage

If your business has suffered a demonstratable financial loss due to one or more of these, please contact us.

## **Business support**

Compensation for substantiated financial losses as well as other help is available for businesses directly affected by our flood works. If your business has suffered as a direct result of our construction activity, we would like you to get in touch. You can contact us in a number of ways:

### Be winter ready

It is important that you are prepared and know what to do if flooding threatens. We encourage you to take 4 simple steps:-

- 1. Sign up to the Flood Warning Service to receive free flood warnings
- 2. If you have property level flood barriers, check these are in working order
- Know what to do when a flood warning is issued. Have a flood plan 3.
- Keep an eye on the situation. You can view at 5 day weather forecast and 4 monitor river levels online at https://flood-warning-information.service.gov.uk/ and www.metoffice.gov.uk/public/weather/
