The piling works and insertion of king posts along the river are progressing well. The piling has commenced further down stream towards Edgecombe Court and will continue down stream once the remedial work to the existing wall has been carried out. These works will take place each Saturday for 4 weeks commencing Saturday 19th July.






Waterside Café is fully back open. The café can be accessed from Miller Bridge end. The footpath will remain closed below the café to Edgecombe Court. Barriers will remail in place along the river to provide additional noise and dust protection from the works being carried out.

Footpath diversions will be in place.











What are we doing?

Piling works continue along the river, The piling is in front of the existing wall to construct a flood defence wall. The Spiral flush method of piling is used to pile a casing down into the ground before filling with concrete. In this area the piling will be between 6.5m - 9.8m deep. The casing will be a minimum of 2.25m deep into bedrock to prevent water rising underground. Once the piling hole is completed a kingpost is inserted and concrete poured into each pile hole as the foundations for the wall. As we move down stream towards Edgecombe Court the existing wall will need remedial works of repair to enable the piling to continue. The repair works will be taken place each Saturday over the next 4 weeks.

We are constantly reviewing noise and vibration data and undertaking visual and structural surveys within the vicinity of the works. Frequent water sampling in the river ensures levels of silt are kept to a minimum to protect fish and wildlife.

The construction works is a collaboration with the Environment Agency, WSP design team, VolkerStevin delivery contractor, VGE, and Kellers, the piling specialists.

The next steps will include;

- King posts will be placed into the pile holes working from Waterside Café down towards Edgecombe Court.
- Pouring the concrete foundations to start the construction of the flood wall
- Flood wall to be cladded in locally sourced natural stone
- Glass panels to be installed on top of the flood wall.
- Noise and vibration will be constantly monitored during the construction activities
- Footpath closure will remain in the vicinity of the works during construction

Protecting the Environment



An Independent Ecological Clerk of Works will monitor all activities and will have a regular presence on site over the coming months. This is an important role that oversees all site preparation and construction works associated with biodiversity. This is to ensure safe working, and protection of the local environment is undertaken in accordance with legislation and best practice.

Pre-construction surveys have been carried out and include, but are not limited to; otters, breeding birds, invasive non-native species, trees and white-clawed crayfish as well as many other species such as salmon. Spawning grounds are known and monitored in respect of salmon and trout on all rivers and tributaries within the Kent catchment.

Full consideration has been given to the in-river working platform and bank stabilisation bags. Consent has been granted for these works to be undertaken and will be monitored by our Independent Environmental Clerk of Works.

Otter

All our activities around, or near European Protected Species are carried out under licence, and we will put in place measures to mitigate against impacts from any of our works. We will install environmental monitoring which will monitor noise, vibration and vehicle movements in sensitive locations so we can take further measures to mitigate against any risk of environmental

harm.
